SHARON ADAMS

When KPFA management abruptly cancelled the Morning Mix program during a pledge drive, I, Sharon Adams, became involved. The Morning Mix was produced locally with a variety of hosts addressing issues of local, regional and national concern. The controlling majority on the KPFA Local Station Board supported replacing the Morning Mix with a recorded production from LA, arguing the recorded production would generate more revenue. The LA-produced show has failed to increase revenue, while cancelling the Morning Mix removed local voices from one of the prime drive-time listening hours. KPFA and its parent, Pacifica Foundation, have amazingly bad basic accounting methods that appear to be standard operating procedure. A required audit from 2013 was just finalized, while the 2014 audit remains unfinished. I was on the Board of Directors for the National Lawyers Guild-San Francisco Bay Area Chapter, from 2007 until 2014, while the economy suffered a major recession. The NLG is a non-profit, membership organization, similar to Pacifica/KPFA. We kept the NLG financially solvent by responding appropriately and in a timely manner to the financial challenges. Please vote for me and the entire United for Community Radio slate, www.unitedforcommityradio.org, to bring effective oversight to KPFA programming and finances.

MARILLA ARGÜELLES

I, Marilla Argüelles, have developed, provided, and advocated 30 years for services to combat trauma, deprivation, and stigma. An artist and teacher, I've battle bureaucratic obtuseness and lack of funding with creativity and Socratic obstinancy. In 1983 Barbara Lubin and I co-founded the East Bay's first integrated, accessible children's recreation program. In 1984 I founded Consensus, California's first nonprofit head injury rehab program to receive Adult Ed funding. As Community Colleges became more inclusive, our focus morphed into media projects at underachieving high schools. Students created Powerpoint presentations on child slavery, criminal injustice, agribusiness, and The Patriot Act. In 1993 Flashpoints led me to the California Prison Focus, where Bato Talamantez graciously allowed me to edit letters from the SHU at Pelican Bay into an anthology lauded by Adrienne Rich, Carlos Muñoz, June Jordan, and the BBC. I've spent equal time and heartache serving on Union Contract Negotiations and Executive Boards. As former president of SEIU 616's IHSS providers, I'm keenly aware of the need for fiscal vigilance, transparency, and resilience. I'm joining UnitedForCommunityRadio (RadioUCR.org) to replace corporate obsessions of profit, growth, and technology with local democratic economies geared towards Justice and Survival.

VIRGINIA BROWNING

Virginia Browning – Incumbent board member, former radio programmer, activist. Previously, KPFA Election Committee. Currently, Pacifica National Programming and Governance committees. I joined many in the 90s taking back KPFA & Pacifica from an unaccountable national board. New bylaws, listener and staff-crafted, were adopted. Bylaws oversights allowed for a new hierarchy. Change is again essential for Pacifica's survival. VOTE UNITEDFORCOMMUNITYRADIO.ORG Pacifica is license-holder to KPFA and four other stations. Successes and failures of each station affect all others: Most of Pacifica's Texas audience had no signal for over a year. Pacifica's auditor, owed \$55,00, can't begin a year-behind audit required for funding millions of dollars. KPFA spends thousands on new carpets. KPFA revenue decreased \$406,000 since 2012. Expenses increased \$51,000. "Community Radio" broadcasts a range of progressive views. Strengthen new voices to speak for themselves, not filtered only through a cream-top few. A recently-deceased world-renowned KPFA programmer, seldom-promoted here, said collaboration produced his best work. We can work together! In light of massive conglomeration of media everywhere, we must vote to keep Pacifica alive and strong.RadioUCR.org, and "Daniel's Free Speech Zone." Rank ONLY UCR candidates. I will work to restore the former high level of KPFA's news and public affairs programming necessary for listeners to understand critical issues requiring attention and action. KPFA's longstanding policy has been to sponsor vigorous debate from all viewpoints on controversial issues. Current management policy appears to avoid controversial issues via censorship. It has refused to air at least one program because of content. I am concerned about the dumbing down of my hometown radio station by KPFA management and the current local station board majority. For two years management has neglected to apply for millions of dollars in CPB grants, resulting in financial stress and degraded news content. I will work to restore proper financial auditing so this funding can be regained. I started in community radio through journalism and radio shop at El Cerrito High School. I was an engineering volunteer at KPFA in the 1960s. In the 1980s I was a consultant to the Sandinista civil infrastructure for radio broadcasting. BARBARA WHIPPERMAN

Barbara Whipperman, Listener Candidate for the KPFA LSB, currently serving as KPFA/LSB Treasurer. A listener since 1955, active supporter answering phones during fund drives, I marvel at how long KPFA supporters have kept it alive, even through difficult times. We've recently recovered some stability with new management. Turmoil is lessening, hopefully to be replaced by more cooperative efforts.
