#### Dear Ms. Serpe:

TrueBallot, Inc. was appointed Impartial Balloting Agency to administer the conduct of the ballot with respect to the 2016 Local Station Board Elections for KPFA, KPFK, KPFT, WBAI and WPFW. The ballots were tabulated in our office in Merced, CA at various times between October 3 and October 17, 2016.

The ballot and materials were approved as to form. A total of 49,531 ballots for all stations were sent to eligible voters on August 15, 2016. 1808 ballots were returned to TrueBallot as undeliverable. Undeliverables were updated daily during the open election period. In addition to this mailing, email requests and reminders to vote were sent on five occasions to all qualified voters for whom the Foundation had an email address: August 25, September 3, September 13, September 21, and September 27. Of the 1808 members whose ballots were returned undeliverable, the foundation had 884 email addresses, and the Foundation attempted to reach these individuals as part of the email blasts.

A total of 379 voters were added over the entire election period from all stations by the various Local Election Supervisors, and the details of when they were added and how they received their credentials can be found in the electronic records of the election.



Ballots were returned to the TrueBallot post office box in Merced, CA during the open election period. TrueBallot scanned the barcodes of returned ballots as they arrived in order to provide weekly reports to the Foundation, assisting the stations in meeting quorum.

The election was originally scheduled to close at midnight ET September 30, 2016, and it did close at that time for KPFA and WBAI (except for three WBAI ballots accepted late by the National Election Supervisor). The election was extended to October 7, 2016 at KPFT and WPFW in order to ensure that they were able to meet quorum, and to October 10, 2016 at KPFK for various reasons.

A total of four paper ballots (all elections) were received with no ID, and were set aside uncounted. Thirty-eight envelopes were received with credentials and/or donations to the Foundation, but no ballot. Thirteen voters (all elections) voted both online and on paper; their web ballots were included in the final count, and their paper ballots were removed from the final count.

After the ballots were registered, TrueBallot, Inc., opened the envelopes, optically imaged the ballots and processed them to create STV ranking strings in a format countable by the open source Choice Plus Pro program. These strings were then run through Choice Plus Pro, and the STV count was run. For the WPFW Listener Election, ten write-in candidates were disaggregated from the write-in pile, assigned individual numbers, and added to the ranking strings. Three write-in candidates were elected to the Board. In all other elections, aggregate write-ins fell outside the top nine (listener) or top three (staff) elections, so the individual write-in names were not disaggregated. TrueBallot is aware that the Foundation has requested more detailed



write-in reports for the elections in which write-ins have not been disaggregated. TrueBallot will disaggregate some or all names from those elections as requested.

The results of the STV count were originally publicized on October 15. The results of the balloting are herewith certified and are attached hereto. The final round counts are attached to this document. Details reports indicating how these final round tallies were generated have been provided separately.

It is our opinion as Impartial Balloting Agency that the results of the balloting are true and accurate, the ballots were properly counted, and rigid safeguards were maintained to protect the secrecy of the ballot. At the conclusion of the counting, all ballots and material were placed in appropriate containers, sealed and will be shipped to the organization for storage. Electronic copies of all of the ballot data and ballot images will be delivered along with the physical ballot materials.
